Centennial Theatre Society Grant for Performing Artists

Centennial Theatre is a 700 seat venue operated by the City and District of North Vancouver through the North Vancouver Recreation Commission. The Centennial Theatre Society is a not-for-profit organization that raises funds to support performing artists and organizations with the rental costs of Centennial Theatre.

Program Guidelines

The program exists to offset rental costs for performing artists and organizations to present a performance to a community audience at Centennial Theatre.

Eligibility

- Any performing artist or organization within the lower mainland of British Columbia that can fulfill the program criteria is invited to apply.
- Priority will be given to North Vancouver residents or organizations when submissions of equal interest are made.
- Priority will be given to initiatives that feature young performing artists.
- Priority will be given to new initiatives or organizations.
- Existing Centennial Theatre rental clients are welcome to apply in support of new initiatives.
- Successful applicants are welcome to apply again in future years. Unsuccessful applicants are encouraged to apply again for the same event unless instructed that the project was ineligible.
- Applications for fundraisers or events that benefit political or religious organizations will not be considered.
- Centennial Theatre Society may withdraw the grant funding for this program at its discretion. In such a case, any eligible applications submitted will be carried forward for review in the next cycle.
- Centennial Theatre Society may withhold payment of the grant if the successful applicant changes its event or is not meeting the requirements of the rental contract.

Program Criteria

The successful applicant will host an event at Centennial Theatre that best meets the following criteria:

- Showcases or advances the performing arts;
- Showcases or advances North Vancouver residents or organizations as artists or audience members;

- Celebrates or benefits youth;
- Supports new artistic initiatives or fledgling organizations;
- Makes use of the theatre's scale, technical capabilities and seating capacity.

Acknowledgement

The successful applicant will be required to share billing with the Centennial Theatre Society in all printed and promotional material. The successful applicant will acknowledge the Centennial Theatre Society at the event. The successful applicant will provide 8 tickets to the Centennial Theatre Society at no cost.

Details of Support

The Centennial Theatre Society has one grant of \$1,000 available for 2011. The funds will be used to offset costs of the theatre rental. The grant may not be used to defray the costs of cancellation.

A committee of the Centennial Theatre Society Board of Directors and professional staff will select the grant recipient. The successful recipient will be notified by Dec. 20, 2010.

DEADLINE: November 30, 2010

Late or incomplete applications will not be considered.
